### Field Trip 3. Broken Hill

*Broken Hill's massive orebody, which formed about 1,800 million years ago, has proved to be among the world's largest silver-lead-zinc mineral deposits. The orebody is shaped like a boomerang plunging into the earth at its ends and outcropping in the centre. The protruding tip of the orebody stood out as a jagged rocky ridge amongst undulating plain country on either side. This was known as the broken hill by early pastoralists. Miners called the ore body the Line of Lode.*
